## **Non-Examined Assessments, Starting Terms 3, 4 and 5, Years 10 and 11**

Dear Parent

We are writing to inform you of non-examined assessments continuing or starting for students undertaking art and design, creative imedia, dance, digital information technology, hospitality and catering, music, performing arts and textiles, prior to term 6. These assessments are a fundamental part of the course(s) students have opted for and will count towards their qualifying grade.

It is essential that for the duration of each assessment, a student's attendance, punctuality, behaviour and effort are of the highest standard, to maximise the quality of evidence students are able to produce and subsequently submit. Each assessment will differ depending on the subject; however, all students will be asked to produce evidence, independently based on a task provided by the examination board, submitting this by the deadline provided. Depending on the assessment, the evidence will either be marked by their teacher following the deadline with students notified of their raw mark before submission to the examination board; or evidence will be sent to the examination board for marking.

Further guidance of the timing of each assessment has been provided on the following page. As previously mentioned, all the assessments listed will count towards a student's final qualifying grade for the qualification(s) they have opted for. If a student's conduct falls below the expected standard, then their final grade for the qualification could be affected.
